Helpful Terms:

Placement

A term used to describe moving a person to a care facility.

Care Placement Agencies

Agencies that assist people in locating care facilities that meet their needs.

Independent Living Facilities

Privately owned homes or complexes that provide housing for adults who do not need medication oversight, are able to function without supervision and can live independently. They often provide services and amenities such as housekeeping, social activities, and dining opportunities. There is no oversight or licensing agency for these facilities and the cost is not covered by medical insurance.

Residential Care Facility for the Elderly (RCFE)

Residential Care Facilities for the Elderly serve persons 60 and older. They provide room, board, housekeeping, supervision, and personal care assistance with basic activities like personal hygiene, dressing, eating, and walking. Facilities usually centrally store and distribute medications for residents to self-administer. These facilities are licensed by the California Department of Social Services (CDSS), Community Care Licensing (CCL) Program in the State of California.

Assisted Living Facility

A facility licensed to provide a living arrangement for people with special needs, especially seniors with disabilities. It provides help with everyday tasks such as bathing, dressing and taking medication. The services provided may vary. The cost is not covered by medical insurance but may be covered by long-term care insurance.

Board and Care Home

A home licensed to provide services such as meals, medication supervision, and assistance with bathing, dressing and eating. Most facilities are licensed for six or fewer residents, but some are larger. The cost is not covered by medical insurance but may be covered by long-term care insurance.

Memory Care Facility/Unit

A facility that specializes in caring for the needs of individuals with varying degrees of dementia. These facilities provide dementia care and are equipped with safety features and around the clock supervision. The cost is not covered by medical insurance but may be covered by long-term care insurance.

Skilled Nursing Facility (also Nursing Home, Convalescent Home or Rehabilitation Hospital). An inpatient facility, licensed by the State of California and Medicare, that provides 24-hour nursing services to persons in need of extended care.
